Re: Attendance & Parent Survey

Yesterday we sent out some letters regarding attendance; some informed parents that their child's attendance is a concern (below 90%) and some informed parents that their child's attendance was considered "good" (above 96.1%).

Ofsted consider that 96.1% and above is what a "good" school must achieve in their attendance. At present our whole school attendance is 94.5% so this is something that we need to improve as the school cannot be classed as "good" in an Ofsted inspection if our attendance does not meet the criteria.

Obviously you cannot bring your children to school if they are not well enough to attend but it would be really helpful if unnecessary time off school could be avoided e.g. routine dental or medical appointments or other non-urgent engagements. If an urgent appointment is unavoidable during school hours, we would appreciate it if your child attended school before and after the appointment where possible.

It would be wonderful if we could reach our goal of 96.1% or above for the whole school attendance during this coming term and we would be very grateful for your support with this.

Attached to this letter is a parent survey which we hope you will be able to fill in and return by May 14<sup>th</sup>. The survey will help us to improve our school and the provision we give to all our children. Please feel free to add extra comments and also to ask any questions you would like answered.
